**ORDER DIRECTING JOINT ADMINISTRATION OF
RELATED CHAPTER 7 CASES**

Upon the Motion (“Motion”, D.E. 45) of Joseph W. Grier, III, court-appointed Chapter 7 Trustee of TSI Holdings, LLC, WSC Holdings, LLC, SouthPark Partners, LLC and Sharon Road Properties, LLC (together the “Bankruptcy Cases”), for entry of an order, pursuant to Section 105(a) of Title 11 of the United States Code and Rule 1015(b) of the Federal Rules of Bankruptcy Procedure, authorizing and directing the joint administration of the Debtors’ related chapter 7 cases for procedural purposes only; and due and sufficient notice of the Motion having been given; and it appearing that no other or further notice need be provided; and upon the record therein; and it appearing that the relief requested by the Motion is in the best interests of

the Debtors' estates, their creditors and other parties-in-interest; and after due deliberation and sufficient cause appearing therefor;

IT IS HEREBY ORDERED THAT:

1) The Motion is GRANTED;

2) The above-captioned chapter 7 cases shall be jointly administered for procedural purposes pursuant to Federal Rule of Bankruptcy Procedure 1015(b) such that a single docket and single pleadings file in Case No. 17-30132 will be used for matters related to the administration of the Debtors' respective bankruptcy estates;

3) That a docket entry shall be made in each of the Bankruptcy Cases substantially as follows:

“An Order has been entered in this case directing the procedural consolidation and joint administration of the chapter 7 cases of TSI Holdings, LLC, WSC Holdings, LLC, SouthPark Partners, LLC and Sharon Road Properties, LLC and the docket in Case No. 17-30132 should be consulted for all matters affecting this case.”

4) In the future, all pleadings, motions, notices, orders and other papers for any of the Debtors will hereafter be filed under Case No. 17-30132 and such filed documents shall be entered on a single docket.

5) Joint administration of the Debtors' estates shall include:

(a) the combining of notices to creditors and parties in interest;

(b) the scheduling of hearings;

(c) the preparing by professionals of combined fee applications for the Debtors;

and

(d) the joint handling of other administrative matters.

6) This Order does not divert or otherwise effect a substantive consolidation of the above-captioned cases, and nothing contained herein shall constitute a waiver of any substantive or procedural rights of any party in interest in these chapter 7 cases.
